Certainly, this has been an amazing year!



Dr. Bruce Lane Assistant Principal for Pupil Personnel Services (PPS)

## NEW PPS ASSISTANT PRINCIPAL

At its March 12 meeting the Board of Education of CUSD 303 approved the employment of Dr. Bruce Lane as Assistant Principal for Pupil Personnel Services at St. Charles North High School. In this position, Dr. Lane will provide leadership in the coordination of those comprehensive services that relate directly to students outside of the classroom. Those services include all aspects of guidance and counseling, college and career plans as well as attendance and discipline.

Dr. Lane most recently has served as Principal of the Aurora Community School. Prior to that position, Dr. Lane served as Assistant Principal for Student Services at Woodstock High School in Woodstock. Other experience includes Assistant Principal, Student Support Team Coordinator and Social Worker at Lyons Township High School in LaGrange. He began his career as a Social Studies teacher with the Black Hawk College Area High School Program in Moline, Illinois.

"I believe that building level administrators play a critical role as catalysts and facilitators for schoolwide actions that help students to become actively engaged in the learning process, assume personal responsibility for their lives, show respect for themselves and others, and acquire the social and cognitive skills necessary to succeed in the working world" said Lane. Lane completed his undergraduate work in Sociology at Eastern Illinois University in Charleston, Illinois. He earned his Master's Degree in School Social Work and his Doctorate in Educational Organization and Leadership from the University of Illinois in Champaign.

"Dr. Lane brings a broad perspective and a wide array of experience to District 303", said Mr. Frank Kesman, Principal of North High School. "He will exert positive leadership as we work to bring a team approach to our student services program".



The St. Charles North High School Mock Trial Team is an academic team in which students assume the roles of attorneys and witnesses in preparation for competition with other schools. A case, which is provided by the State Bar Association and Local Bar Association, is argued both from the plaintiff/prosecution and defense side. In competition, each side of the case is argued and heard by real judges and lawyers and scored accordingly.

This year, the newly formed St. Charles North High School Mock Trial Team competed in the Annual Kane County Bar Association High School Mock Trial Program at the Kane County Judicial Center on April 27, 2001. The North Stars argued the defense side of the case, which involved a patron suing the local grocery store (defendant) for negligence. The group of Sophomore Alex Bradley (attorney), Sophomore Ryan Johnson (attorney), Greshman Oliver Osinga (witness), and Freshman Tim Timberlake (witness) successfully argued and won their case against a tough Batavia High School Team, which consisted of upper class students (juniors and seniors). These young men are to be commended for the hours of hard work and dedication.

#### ALGEBRA AXT HISTORY Biology FRENCH English 101

As the quote from Einstein shows, if schools simply repeat the use of the same educational strategies, static results will follow. Therefore, we need to continue to ask ourselves – "what new curriculum, instruction, and assessment practices can be put in place to achieve new / improved results in student learning?" However, one may wonder - when do teachers and administrators tackle the lion's share of this work – the reflection, revision, and/or creation of new courses and curriculum? June, July, and August!

The culture and climate of STC North is one where teachers, not just students, learn. Here, teachers focus on their own practice and their conversations center on the direction in which the curriculum can lead student thinking. They try new approaches, monitor the effects, and reflect on the successes and failures. In brief, improvements in teaching and learning are nurtured and supported by our culture of collegiality and innovation.

Examples of summer curriculum and course work in which a variety of STC North staff will participate include:

- *Teambuilding* course; an opportunity for all North team teachers to build/strengthen personal and professional relationships, to refine course structures and objectives, to establish purposeful roles, and to begin to co-plan curriculum.
- Standards and Assessment work; teams from Social Studies, English, Science, and Foreign Language will work to refine learning standards, clarify/write new course indicators, and create common assessments to measure the extent to which students have met standards.
- *Curriculum Renewal*; teams of teachers from Chemistry, Spanish, Geometry, Biology, Physics, and C++ will work to align and enhance the existing curriculum.
- Advanced Placement Training; teachers from Biology, Calculus, and C++ will attend extended AP Conferences held at local Universities to learn about

new curriculum frameworks and innovative testing protocols.

- *RRC Challenge* Course; staff members will explore a wide variety of practical diagnostic, interventive, and preventative strategies for managing today's classroom and re-directing challenging behaviors toward respectful, responsible, and cooperative participation.
- Understanding by Design Course; in this course teachers will explore answers to the questions; "How will we know that students truly understand and can apply their knowledge in a meaningful way?" and "What instructional strategies are both engaging and effective for developing student understanding?"
- Assessment Camp at North HS; new and experienced STN teachers will examine current research and create high quality assessment tools that are aligned with fair grading practices.
- Graduate course work at local Universities

The professional development work of teachers and administrators serves to improve the quality of curriculum and instruction we provide to the students – but it also serves as a mechanism to renew teacher's enthusiasm for the profession. Michael Scott Cain (2001) sites ten major qualities of renewed teachers, they:

- 1. have a philosophical center
- 2. have a commitment to students, to lifelong learning, and to the school
- 3. are aware that they are an integral part of the school
- 4. have a sense of personal responsibility
- 5. have a strong love for all aspects of life
- 6. have the ability to see all students as individuals
- 7. have the ability to communicate
- 8. exhibit a sense of collegiality
- 9. have a strongly developed sense of leadership
- 10. separate their egos from their work

The investment of time and resources in summer staff development is a Win-Win situation for the entire school community.

## "An Update"

The fourth quarter of this school year took us all by surprise. Certainly, no one expected that North and East High Schools would come together to complete the school year. I was often asked, "How are things going"? Bringing two schools totaling 3,500 students and 275 staff members together was not a simple task. I am appreciative of the many conversations, notes and telephone calls of support.

Our students were a significant reason behind our success. The leadership and the staff of the two schools planned a transition, and worked to establish a climate of cooperation. But, it was the day-to-day behavior of the students from both schools that proved to be the deciding factor. Our students opened their school and extended their friendship to their peers from East High School. Not every accounting you may have read in local newspapers accurately reflected the positive relationship that existed in our hallways. Was the situation consistent with our expectation of excellence? I would say that was not the case. We reduced instructional time and caused many families to adjust their daily schedules. Teachers and students were brought together in an unusual set of circumstances. However, given the time to prepare and the limitation imposed by existing facilities, I believe our students accomplished much.

A 50+-member committee of parents, students, staff and administration is presently working on identifying possible schedule options for this September. Five different possibilities reflecting various stages of availability of East High School are the focus of the committee's work. An initial update was provided to the Board of Education at their June 11<sup>th</sup> meeting with a follow up discussion at a special meeting scheduled for June 18<sup>th</sup> in our auditorium.

While the options are many, the information and recommendations shared with the Board of Education will reflect the following established criteria:

- Provide contact time which is comparable to the typical District 303 high school schedule.
- Provide access to District 303 curriculum, course selection and support services.
- Provide students access to District 303 co-curricular activities and athletic programs.
- Consider the impact on families throughout District 303.
- Provide access to transportation, food and maintenance services.
- Allow for the culture and traditions of all schools in District 303.

Since no one knows what portion of East High School will be available to students, all alternatives must be discussed, with preparations in place for possible implementation. A safe re-entry to East High School and timeliness are critical elements for our students. I would encourage you to be pro-active and express your position and concerns by contacting your Board of Education members, local and state officials and Regional Superintendent, Clem Mejia. The students and staff of St. Charles North High School are prepared to be active participants in the resolution of this issue. Only by working together can the best possible opportunities be made available for our students.

- <u>Summer School</u> Registration for the second session of summer school (July2 – July 20) will be taken in the North High School Guidance Office throughout the month of June. Many classes fill up quickly so you are encouraged to enroll as soon as possible. For the first time <u>Enrichment Courses</u> (not for credit) will be offered during summer school in many areas of study this summer, including Photography, Drawing, Writing, Film Study, Wood Technology, and Reading.
- Information on College of Dupage's <u>Teens on</u> <u>Campus</u> summer school offerings is also available in the Guidance Office. The Teens on Campus Program offers a wide variety of high school credit classes taught at several locations (i.e. Carol Stream and Glen Ellyn). In order to receive credit at North High School for these courses, students must complete an "Alternate Schedule Request" form and gain our school's approval PRIOR to enrolling in this coursework.



### What To Teach Your Kids Before They Leave Home

#### HANDYMAN SKILLS

- □ Hang a picture straight without making extra holes in the wall.
- Paint neatly, including cleaning up the mess.
- □ Know which tools perform what functions and how to use them around the house.

*Extra credit:* Sharpen a knife without cutting yourself.

#### **OUTDOOR SKILLS**

- Hike with friends all day without getting lost, bitten, or covered with a rash.
- Bait a hook, catch a fish, reel it in, remove the hook, then clean and cook the fish.

## Plan and manage a weekend camping trip with friends.

*Extra credit:* Know enough about the wildlife in your area to recognize and feel like a friend to the animals.

#### PRACTICAL SKILLS

Type well with both hands in the normal manner.

Set up your own computer system without help from anyone.

 Drive a car, including one with a manual transmission, and maintain it properly.

*Extra credit:* Change a flat tire.

#### ORGANIZATIONAL SKILLS

- Create a budget. Note: It takes longer to earn money than to spend it.
- □ Balance a checkbook manually, even if you bank online.
- Maintain an address book and a personal appointment calendar.

*Extra credit:* Set up a filing system to keep all of the paperwork in your life in one place.

#### SOCIAL SKILLS

- Carry on a conversation for 15 minutes with a person you don't know.
- Speak before a small group of friends for a few minutes.
- □ **Tell a joke** well enough so that everybody gets it and maybe even laughs.

*Extra credit:* Learn enough ballroom dancing so you can have fun at parties. (Trust me on this one!)

#### ARTISTIC SKILLS

- Draw an illustration at least well enough to get your point across.
- □ Have enough confidence to sing along, even when everyone else can hear you.
- Know how to play a musical instrument well enough to enjoy playing in a group.

*Extra credit:* Learn how to take a decent photograph, so you won't be disappointed later, when it's developed. For example, you can't shoot fireworks with a flash!

#### HUMAN SKILLS

- Care for a dog, cat or other animal, including when it's sick.
- Baby-sit for children ranging in age from 6 months to 6 years.
- Aid elderly or handicapped people without looking superior.

*Extra credit:* Help a person in need without exposing either one of you to danger.

#### **ORIENTATION SKILLS**

- Get around town on a bus, even if you usually walk or drive.
- Read a map, including road maps.
- Know what to do if you find yourself in a bad neighborhood.

*Extra credit:* Know which direction is north, south, east, and west (without a compass) whenever you're outside.

#### **RECREATION SKILLS**

- Play a team sport instead of just watching.
- □ Maintain a fitness regimen.
- Learn a game (like bridge or chess) you can play with friends for life.

*Extra credit:* Know how to ride a horse, handle a boat, or enjoy a snow sport.

#### SURVIVAL SKILLS

- **Know basic** first aid and maintain a complete first-aid kit.
- □ Know what to do it you get sick, especially if you're alone.
- □ Know when to defend yourself; then know how to be effective.

*Extra credit:* Know CPR. The life you save may be your father's or mother's.


### TIME CAPSULE CEREMONY

HUMANITIES LEARNING AREA



In order to better understand the components of our Learning Area, we share the following definition with you. At SCNHS we define the Humanities as:

> The Humanities are the creations of humans expressing the human condition. The Humanities are a manifestation of what is fundamental to the human endeavor as shared across time in the creative outpouring of all peoples, namely through architecture, drama, literature, music, and visual art - including photography and film. To study the Humanities is to study the record of human experience as conveyed in the artistic endeavor of thousands of years of human history. The Humanities and the study of Humanities moderate the objective knowledge of science and mathematics, thereby providing a more complete and richer context for the discovery of human understanding. At SCNHS the Humanities are the blending of three separate, traditional disciplines, Art, English, and Music, into one Learning Area: Humanities. (reprinted from the St. Charles North High School *Course Offering Booklet*)

This summer English teachers will be working on "focusing" the District's Language Arts learning standards. Our work will involve a review of the current standards, a division of those standards into age appropriate target standards (meaning we will coordinate the "focusing" of certain standards at certain grade levels), and the rewriting of appropriate indicators.

Furthermore, we will begin our music standards work - in earnest - next year as we seek to define high school level music standards for the District. We hope the data collected from the ISAT Fine Arts assessment, given to each sophomore in early April, will go a long way to clarify these music standards.

### The Greater St. Charles Education Foundation

As part of its efforts to enhance education opportunities for the students of CUSD 303, the Board of Directors of the Greater St. Charles Education Foundation has established as a priority the Project Grant Program.

The Foundation has accepted the following grant proposals written by St. Charles North High School staff members for the 2001-02 school year:

- <u>Balanced Band Instruments Grant</u> for \$2,400 was written by Jim Stombres, Band Director. This money will be used to purchase band instruments for student usage. The focus of this grant was on the continued implementation of balanced instrumentation in our Band Program at North High School.
- Power of The Web Grant for \$4,663 was written bv Brian Wegley, Instructional Coordinator for Science & Technology/ Math & Business Education. This money will be used for developing on-line materials for student and staff usage. (i.e. Creation of interactive and individual learning situations that will be customized for each learning area. Creation of practice tests to aid with student's mastery of content - Student comprehension of content long-term learning been and have demonstrated to increase with such individual accountability.)
- <u>Sister School Program Grant</u> for \$4,000 was written by Sharon Soper, Foreign Language Instructor. This money will be used to help fund an Electronic Sister School Program for which District 303 has no funds. This program would enable students to be matched to other schools around the world in an attempt to provide a means for the students to communicate with each other on a daily basis.
- **Digital Imaging to go Grant** for \$4,000 was written by Linda Goll, Art Instructor. The Greater St. Charles Education Foundation grant for 2000-01 school year enabled NHS to purchase one G-4 computer and monitor for visual arts areas. This money for the 2001-02 school year will be used to build on that foundation for a "portable digital imaging station" which could be used anywhere in the

building. This equipment will be used by all Learning Areas as a resource for digital imaging and multimedia presentations.
